(b) and (c) In exercise of the powers conferred by Section 99A of the Code of Criminal Procedure (1898) Delhi Administration issued orders, vide their Notification No. 292|67-C, dated the 6th December, 1967 for the forfeiture of this book on the ground that it contains matter which promotes feelings of enmity and hatred between Hindus and Muslims in India and its publication is punishable under Section 153A of the Indian Penal Code. A copy of the notification has been sent to all State Governments and Union Territory Administrations and it would be for the State Governments to take whatever action they consider appropriate against the author, publisher and printer of the book. The question of prosecuting the writer, printer and publisher of the book is stated to be under consideration of the Government of Maharashtra.]

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SHRI BHAGWAT JHA AZAD):
(a) and (b) The percentage of administrative expenditure has been showing a downward trend (in recent years) since 1963-64.

(c) and (d) Yes, Sir. The Council has made efforts to reduce the administrative expenditure as much as possible by keeping some long-term vacancies unfilled, by not appointing leave substitutes and by effecting economies on other items of expenditure also.
