ICE SKATING RINK IN SIMLA

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH): (a) and (b) No funds nave been sanctioned for the construction of a all-weather ice-skating rink at Simla, as the details are still awaited from the State Government. As this is a part II scheme, the State Government will be responsible for its operation and maintenance.

SECESSIONIST TENDENCIES AMONGST STATES

*206. SHRI N. SRI RAMA REDDY: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) what are the States where secessionist tendencies have sprung up in the recent past; and
- (b) what steps are being taken by Government to put an end to such tendencies?

THE MINISTER OF HOME AF-FAIRS (SHRI Y. B. CHAVAN): (a) and (b) The Mizo National Front has persisted in its unlawful activities in the Mizo Hills District of Assam and has been declared to be an unlawful association under the Unlawful Activities (Prevention) Act, 1967. The separatist poster campaign and the activities of the Lachit Sena in some parts of Assam as well as the activities of some groups in Manipur have come to notice as secessionist in character and they are being closely watched. The Central Government are in touch with the Governments concerned regarding action to be taken.

SEPARATE GOVERNOR FOR NAGALAND

327. SHRI R. P. KHAITAN: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether Nagaland has put forth a demand that a separate Governor should be appointed for the State; and
- (b) if so, the reaction of Government thereto?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA):
(a) Yes, Sir.

The recommendations of the Conference for the development of the shipbuilding, shippepair and marine ancilliaries industry are under consideration of the Government.
