

of the country's population and difficulties in making selective discrimination is fraught with difficulties of management, and finding defence personnel and equipment required for training and expense. It is doubtful if there is real necessity for such a scheme. In the circumstances it is practical wisdom, to proceed on the limited basis indicated above.

KNOWLEDGE OF HINDI BY THE MEMBERS OF THE CENTRAL BOARD OF FILM CENSORS

1010. DR. (MRS.) MANGLADEVI TALWAR: Will the Minister of INFORMATION AND BROADCASTING be pleased to state whether the members of the Central Board of Film Censors have the requisite knowledge of Hindi or other languages for the censor of Hindi and other Films?

THE MINISTER OF INFORMATION AND BROADCASTING (SHRI K. K. SHAH): Yes, Sir. However in so far as the examination of films is concerned it is done by examining committees consisting of members of Advisory Panels, and an officer of the Board who possess the requisite knowledge of the language of the film including Hindi.

ANTI-INDIA PROPAGANDA BY RADIO PEKING

1013. PROF. SHANTILAL KOTHARI: Will the PRIME MINISTER be pleased to state:

(a) whether Government's attention has been drawn to anti-India propaganda carried by the Radio Peking alleging India's plan to take 'complete charge' of the Indian Ocean following the withdrawal of the British fleet in 1971; and

(b) if so, what is the reaction of the Government of India thereto?

THE PRIME MINISTER AND MINISTER OF EXTERNAL AFFAIRS (SHRIMATI INDIRA GANDHI): (a) Yes, Sir.

(b) It is not unusual for Chinese propaganda organs to make utterly baseless statements such as the one above in an attempt to insinuate that India harbours so-called expansionist ambitions towards neighbouring countries. This sort of propaganda is only an attempt to cover up China's own ulterior designs towards the South-East Asian countries. Wherever it is felt necessary Government of India take appropriate measures through their publicity media to convey the correct picture about India's foreign policy.

TAID TO NEPAL

820. DR. (MRS.) MANGLADEVI TALWAR: Will the PRIME MINISTER be pleased to state:

(a) whether Government have recently decided to give aid to Nepal worth Rs. 4 crores; and

(b) if so, what are the details thereof?

THE PRIME MINISTER AND MINISTER OF EXTERNAL AFFAIRS (SHRIMATI INDIRA GANDHI): (a) Yes, Sir.

(b) The aid is being provided for certain development schemes in the field of minor irrigation, education, health, agriculture, horticulture, and village and cottage industries. The funds are to be utilised by the end

of the next financial year, i.e., March 31, 1969. This additional assistance is being given at the special request of His Majesty's Government of Nepal and will be in addition to the schemes already approved under the Indian Cooperation Programme for the 5-year period ending in March, 1971.
