HEAVY WATER PRODUCTION

*332. SHRI KRISHAN KANT: Will the PRIME MINISTER be pleased to state:

(a) the target of heavy water production by 1970; and

(b) what progress has been made in achieving the target?

THE PRIME MINISTER AND MINISTER OF ATOMIC ENERGY (SHRIMATI INDIRA GANDHI): (a) and (b) The Atomic Energy Commission decided to set up a 100-tonne year heavy water plant. The Project is in the planning stage.

SHRI KRISHAN KANT: May I know from the hon. Prime Minister whether the decision in 1964 was that the target of heavy water production by 1970 should be 200 tonnes per year? Has it been revised now?

SHRIMATI INDIRA GANDHI: The target for the completion of this is middle of 1972. I think it is the same target.

SHRI KRISHAN KANT: In 1964 the Atomic Energy Department was saying that the target of production of heavy water will be 200 tonnes per year. May I also know whether at Rana Pratap Sagar the site has been selected and construction work started and what is the foreign exchange component of that?

SHRIMATI INDIRA GANDHI: This does not strictly arise out of this question. I should like to have notice.

SHRI BIREN ROY: Has the Atomic Energy Commission any programme of research into controlled Thermo-nuclear fusion and not fission? Is there any provision for it?

SHRIMATI INDIRA GANDHI: Again, this does not arise out of this question.

SHRI N. SRI RAMA REDDY: I would like to know whether all the heavy water that we are producing in Nangal is being utilised or whether there is any surplus left over. And are we exporting this heavy-water?

SHRIMATI INDIRA GANDHI: We are exporting some.
