Smart Schools for quality education

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MD. ALI ASHRAF FATMI): (a) Yes, Sir.

(b) Under the "Smart School" component of the Scheme "Information and Communication Technology (ICT) @ Sct.ools", one Kendriya Vidyalaya and one Navodaya Vidyalaya in each State/UT would be allocated, subject to availability of funds, non-recurring grant of upto Rs. 25.00 takh for procuring 40 computers and peripherals, and recurring grant of upto Rs. 2.50 takh p.a. for maintenance, consumables, Internet usage and monitoring costs.

Funds have been sanctioned for upgradation of 33 Navodaya Vidyalayas and 31 Kendriya Vidyalayas into Smart Schools, of which one Kendriya Vidyalaya and one Navodaya Vidyalaya are located in Maharashtra.

(c) Setting up more Smart Schools depends upon receipt of feasible proposals from Kendriya Vidyalaya Sangathan and Navodaya Vidyalaya Samiti.
