**695. SHRI SHANTILAL KOTHARI:  
SHRI S. K. D. PALIWAL :**

(a) whether the Setalvad Study Team of the Administrative Reforms Commission has submitted its reports on the Centre-State relationship;

(b) if so, the details of the report; and

(c) the steps being taken by Government to implement those recommendations?

**THE MINISTER OF STATE IN

(SHRI VIDYA CHARAN SHUKLA) :** (a) The Study Team has submitted its report to the Administrative Reforms Commission.

(b) and (c) The recommendations are contained in the report of the Study Team, copy of which has been placed in the Parliament Library. These are for the Administrative Reforms Commission to consider. The Commission has yet to submit its recommendations on the subject to the Government. The question of implementation therefore does not arise at this stage.

**THE MINISTER OF HOME AFFAIRS  
(SHRI Y. B. CHAVAN) :**

(a) The Central Government have not intervened directly in any State to deal with the law and order problem.

(b) Police reinforcements were provided to the Governments of West Bengal, Bihar, Gujarat and Jammu and Kashmir during the last six months on the request of the concerned State Governments.
