(b) The Punjab Government have offered an area of about 3000 acres in the Sutlej Bed. The terms and conditions for the transfer of land to Central Government for this purpose, are under negotiation.

CENTRAL ASSISTANCE FOR SINKING TUBEWELLS IN M. P.

- (a) whether the Government of Madhya Pradesh has requested the Central Government to provide financial assistance for sinking tubewells in Madhya Pradesh; and

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHEB SHINDE): (a) and (b) During the visit of the Minister of Food and Agriculture to Bhopal in September, 1967,

the Chief Minister, Madhya Pradesh discussed with him various problems relating to Minor Irrigation. In a subsequent letter to the Union Minister, the Chief Minister requested that the Government of India should help them to obtain a sum of Rs. 20 crores from the Reserve Bank of India or other sources for financing their Tubewell programme and promised to send a detailed scheme relating to sinking tube-wells. The scheme has not yet been received. In the meantime, the Chief Minister, Madhya Pradesh has been informed that owing to paucity of funds, the Government of India is unable to allocate additional funds for Minor Irrigation. The State Government was advised to manage with the existing allocation of Rs. 5.93 crores and to tap the agencies in the non-Plan Sector like Land Mortgage Banks, Agricultural Refinance Corporation, Agro-Industries Corporation, etc. for additional outlay for minor irrigation programme.
