THE DEPUTY MINISTER IN THE MINISTRY OF WORKS, HOUSING AND SUPPLY (SARDAR IQBAL SINGH) : (a) and (b) The request received from the Madhya Pradesh Government has been considered and due to an acute shortage of genera! pool accommodation for eligible Central Government employees it has not been possible to spare general pool residential accommodation for allotment to the employees of Madhya Pradesh Government stationed at Delhi.

TRANSFER OF HEADWORKS M PUNJAB

862. SHRI SURJIT SINGH ATWAL: Will the Minister of IRRIGATION AND POWER be pleased to state:

(a) whether it is a fact that the Chief Minister of Punjab approached him recently for the transfer of certain headworks in Punjab to the State Government; and

(b) if so, the reaction of the Central Government thereto?

THE MINISTER OF IRRIGATION AND POWER (DR. K. L. RAO) : (a) Under the Punjab Reorganisation Act, the control of Ferozepur, Harike and Rupar Headworks was to be taken over by the Bhakra Management Board. The Chief Minister. Punjab has however approached the Central Government not to take over these Headworks. The matter is receiving attention.
