## ELECTRIFICATION OF MADRAS-ARKONAM SECTION

- 877. SHRI T. V. ANANDAN: Will the Minister of RAILWAYS be pleased to state:
- (a) whether it is a fact that electrification of Madras-Arkonam section is to be included in the Fourth Five Year Plan; and
  - (b) if not, the reasons therefor?

THE MINISTER OF RAILWAYS (SHRI C. M. POONACHA): (a) and (b) The electrification of Madras-Arkonam section has not been included in the programme of electrification during the Fourth Five Year Plan but electrification from Madras to Trivelore in the first instance, for operation of suburban services, is under examination. Based on this examination, and availability of funds and foreign exchange, a decision on electrification of the section will be taken.
