THE MINISTER OF EDUCATION (DR. TRIGUNA SEN) : (a) and (b) During the Third Five Year Plan, grants totalling Rs. 40.42 crores were released to various universities for development schemes on sharing or 100 per cent basis. The exact information about the sharing grants and their utilisation by the universities is being collected and will be laid on the Table of the Sabha in due course.

SELECTION OF SCIENTISTS IN C.S.I.R.

Will the Minister of EDUCATION be pleased to state :

(a) whether it is a fact that a selection of Scientists of categories 'B' and 'C' for the Laboratories/Institutes of the Council of Scientific and Industrial Research was made in July or August, 1967;

(b) if so, the names of the scientists selected together with their qualifications; and

(c) the names of the scientists with their qualifications and experience who were interviewed separately for 'B' and 'C' categories?

THE MINISTER OF EDUCATION (DR. TRIGUNA SEN) : (a) Yes, Sir. Selection of Scientists in the categories 'B' and 'C' was made in some of the National Laboratories/Institutes of the C.S.I.R. in the months of July and August, 1967.

(b) and (c) Two statements showing the names of candidates interviewed and selected for the posts of Scientists 'B' and 'C' separately are laid on the Table of the House. [See Appendix LXII, Annexure No. 66.]
