AGE OF RETIREMENT OF GOVERNMENT SERVANTS

- 1015. SHRI B. C. PATTANAYAK: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether it is a fact that there is a proposal under Government's consideration to reduce the age of retirement of Government servants from 58 years to 55 years; and
- (b) if so, by when the decision is likely to be taken in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): No, Sir.

ENGINEERING DEGREE COURSES FOR DIPLOMA HOLDERS

- 1016. SHRI B. C. PATTANAYAK: Will the Minister of EDUCATION be pleased to state:
- (a) whether it is a fact that a number of Engineering Colleges and Institutes in the country have sought for Government approval to start 3-year Degree Condensed Courses to admit diploma holders;
- (b) if so, which are those colleges or institutes;
- (c) whether Government have conveyed their approval thereto; and
- (d) if not, what are the reasons therefor?
- THE MINISTER OF EDUCA-TION (DR. TRIGUNA SEN): (a) and (b) Only two universities, M. S. University, Baroda and Osmania University, Hyderabad had asked for assistance to conduct condensed degree courses in engineering on a full-time basis for diploma holders,
- (c) and (d) The proposals were not approved since according to the All India Council for Technical Education such full-time condensed courses are not desirable and a number of centres have been sanctioned for part-time degree courses specifically for diplomaholders. Special provision also exists at certain universities for the admission of diplomaholders to the regular degree courses and it could be extended to other universities.
