

तथा अन्य फसलों के बारे में फसल सुधार विषयक अखिल भारतीय अनुसंधान परियोजनाओं के अन्तर्गत देश के विभिन्न अनुसंधान केन्द्रों में विकास हुई अधिक उत्पादनशील फसल की किस्मों के बारे में विभिन्न किस्मों के लिए उपयुक्त क्षेत्रों को निश्चित करने के लिए प्रादेशिक तथा क्षेत्रीय आधार पर समस्त देश में समकालिक परीक्षण होते रहते हैं। ऐसे समन्वित प्रयोगों से उपलब्ध दिशा के आधार पर उन क्षेत्रों में, जिनमें विशेष किस्म या किस्में उपयुक्त हैं, अधिक उत्पादनशील किस्मों को सामान्य बुवाई करने के लिए जारी करने के बारे में सिफारिशें की जाती हैं।

(ख) समन्वित परियोजनाओं के अन्तर्गत शुरू किये गये बहुस्थानीय परीक्षण से सामान्य खेती के लिए मुख्य खाद्य फसलों की अधिक उत्पादनशील उर्वरक-उपयुक्त किस्मों और संकर किस्मों को जारी किया गया है। इस सम्बन्ध में निम्न कुछ किस्में उल्लेखनीय हैं :—

1. गेहूं : लरमा राजी, सोनोरा 64, शर्बती सोनोरा, कल्याणमोला, सेफड लरमा, एस० 331, सोनालायका

2. चावल : ताईचुंग नेटिव 1, आई आर-8, ताईचुंग 65, ताईनान 3, एडीटी-27

3. ज्वार : सीएस एच-1 तथा सी एस एच-2

4. बाजरा : एच० बी०-1 तथा एच० बी०-2

5. मक्का : हाईब्रिड हिमालय 123, गंगा 101, गंगा 3, गंगा सेफड 2, दक्कन, रंजीत, हि-स्टार्च तथा कम्पोजिट्स-अम्बर, जवाहर, विजय, विक्रम, सोना तथा किसान।

t[THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND CO-OPERATION (SHRI ANNASAHEB SHINDE): (a) No countrywide survey has been conducted by the Government of India to find out the different varieties of seeds which would be best suited for each area and the types of crops which would yield highest profits when sown in each area. But, under the all-India research projects on crop improvement sponsored by the I.C.A.R., such as those dealing with rice, wheat, maize, jowar and others, simultaneous testing of high yielding promising crop varieties, evolved at the different research centres in the country, is taken up all over the country on a regional and zonal basis with a view to demarcate the area of adaptability of the different strains. On the basis of the data made available by such co-ordinated trials, high yielding varieties are recommended for release for general cultivation in areas to which particular variety or varieties are suited.

(b) Multinational testing taken up under the co-ordinated projects has resulted in the release of high yielding fertiliser responsive varieties and hybrids of the major food crops for general cultivation. Mention can be made of the following releases :—

1. *Wheat*: Lerma Rojo, Sonora 64, Sharbati Sonora, Kalyansona, Safed Lerma, S.331, Sonalika.
2. *Rice*: Taichung Native 1, IR. 8, Taichung 65, Tainan 3, ADT. 27.
3. *Jowar*: CSH. 1 and CSH. 2.
4. *Bajra*: H.B. 1 and H.B. 2.
5. *Maize*: Hybrids Himalaya 123, Ganga 101, Ganga 3, Ganga Safed 2, Deccan, Ranjit, Hi-starch and the "Compositas"-Ambar, Jawahar, Vijay, Vikram, Sona and Kissan.]
