t[THE DEPUTY PRIME MINISTER AND MINISTER OF FINANCE (SHRI MORARJI R. DESAI): (a)

The question apparently relates to the scheme of separation of accounts from audit introduced with effect from the 1st April, 1955 in the Departments of Food, Rehabilitation and Supply. Under this Scheme, the accounting functions in respect of these Departments have been transferred from the Comptroller & Auditor General of India to the Departments concerned. The Scheme also envisaged that all payments would be made by the Departments themselves instead of through the treasuries.

- (b) The Scheme was intended to ensure both expeditious settlement of claims and better control over expenditure against the appropriations granted by Parliament. It is not possible to directly correlate the results achieved with the expenditure involved. However, the Administrative Reforms Commission is also studying the matter.
- (c) Most of the persons who came over from the Comptroller & Auditor General's organisation already hold permanent posts. The question of the confirmation of those who were recruited later, against posts which have recently been made permanent, is under active consideration in the Departments concerned.]
