The principal items of import from G.D.R. will be chemicals, pesticides, muriate of potash, raw films, machine tools, capital goods, laboratory and scientific equipment and iron and steel products. The main commodities to be exported from India to G. D. R. are iron ore, mica, crushed bones, cashew kernals de-oiled cakes, tobacco, tanned hides and skins. coffee jute manufactures, engineering goods etc.
