STATEMENT III

Procedure adopted by the U.G.C. for implementing the scheme of Publication Grants to the Universities

- (1) University may either publish a learned research work under its own supervision and control or get it published through some publisher of repute.
- (2) The interest of the authors must be invariably protected. The copyright should remain with the authors and they may be given some royalty, say, 15 per cent plus a reasonable number of copies, say, 15 to 25 copies, of the work published. The rest of thet ansaclion should be bi tween the universities and the publishers and there should be no business transaction between the authors and the publishers.
- (3) Since assistance of the Commission is intended to supplement the funds already provided by the universities for publication of research and learned work, grants under the scheme may be contingent upon such budget provision being made by the universities.
- (4) The universities may accept for pub-1 ication only such works as are approved for this purpose by experts in the field. The grants may be utilised by the universities for the publication of learned works by the members of the staff or of approved Ph. D. theses or of reports of research projects. It may be desirable to have an assessment of the works to be published by at least two experts, one of whom may be from outside. While universities would depend on the approval and opinion of the Head of Department concerned, the value of expert advice cannot be underestimated. The main consideration is to ensure a high standard of the works to be published. It should be for the universities to decide whether they should have a publication committee or some other efficient device to assess the works to be published and tender advice to the universities.
- (5) The universities may set up a machinery for evaluation or follow up studies of works published during the past five to ten years and take note of the Pi ess reviews etc. The Commission may be kept informed of such periodic reviews.
