## **CLOSURE OF IRON MINES**

(a) the reasons for the closure of the Tata Iron Ore Mines in Gurumahisani and Badampahar and recent retrencn-ment in Noamundi Mines :

(b) whether it is a fact that a large number of Iron Ore loaders on the Rail Heads of Noamundi, Barajmada and Gua are not getting benefit of the recommendations of Iron Ore Wage Board; and

(c) if so, what action Government pro pose to take in this regard?

THE MINISTER OF LABOUR AND REHABILITATION (SHRI JAISUKH-LAL HATHI): (a) It has been reported that the closure of Gurumahisani and Badampahar mines was due to the fact that the required quality of iron ore had been exhausted in the mines and their working has become uneconomic. No retrenchment in Noamundi mines has been reported.

(b) About 350 iron loaders on the rail heads of Barajmada and Gua are not getting the benefit of the recommenda tions of the Iron Ore Wage Board.

(c) The Officers of the Industrial Rela tions Machinery are making efforts to get the recommendations implemented.
