THE MINISTER OF INFORMATION AND BROADCASTING (SHRI K. K. SHAH) . (a) Yes, Sir.

(b) to (d) Applications were received from 15 Scheduled Tribe candidates. Ot these, 6 who fulfilled the qualifications, experience, etc. prescribed for the post, were called for a written test but only two took the test. One Scheduled Tribe candidate was interviewed even though he did not secure the minimum qualifying marks in the written test. He was found by the Selection Committee to be far below the requisite standard. Further action to recruit a suitable scheduled tribe candidate against the reserved vacancy is being taken in accordance with the instructions issued by the Ministry of Home Affairs The post is vacant at present

AT-FAIRS (SHRI SURENDRA PAL SINGH) The majority of the 45 visas given to South African citizens in 1966, and the 65 visas given during the current year, were for visits on religious grounds A few South Africans were permitted to come to India to relatives and friends and to visit places of tourist interest. In accordance with our policy, such visas were strictly confined to cases where we were satisfied that the applicants did not actively subscribe to the policy of apartheid followed by the South Atrican Government.
