(b) Various demands for imported foodgrains have been received from Rajasthan Government at various times. On many occasions the demand was 50.000 tonnes per month.

RESUMPTION OF TELECOMMUNICATION LINK BETWEEN INDIA AND PAKISTAN

(b) The Agreement provides for restoration of all the telephone and telegraph routes existing prior to September, 1965. This has been done on 1st November 1967. Certain procedural details for day to day working such as routine testing, fault removal exchange of traffic and circuit efficiency data, etc. were also finalised.

This Memorandum referred to many points relating to the formulation of national food policy; the important of these were regarding the abolition of food zones. free movement of foodgrains, doing away with the procurement under compulsory levy on producers and discontinuation of the policy of State Trading in foodgrains etc. These points are taken into consideration by the Government while formulating the national food policy.
