### IMPLICATIONS OF THE RESUMPTION OF U.S. ARMS AID TO ISRAEL

\*39. SHRI N. SRI RAMA REDDY: Wil! the PRIME MINISTER be pleased to state:

(a) whether Government have studied the implications of the resumption of the supply of arms by U.S.A. to Israel and some Arab countries; and

(b) if so, whether any assurances are being sought by Government from U.S.A. or the receiving countries with regard to the misuse of the same against India's interests?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH): (a) While the Government have noted the United States announcement last month 2—61 R.S./67 regarding resumption of arms supplies to Israel, Saudi Arabia, Lebanon, Tunisia, Morocco and Libya, it is difficult to consider in detail the implications of the lifting of this arms embargo, as information regarding the nature and amount of supplies involved is not so far available.

(b) The question of diversion of such arms supplies to countries unfriendly to India has been taken up with the United States Government and it is now the U.S. practice to have a clause in agreements for supplying arms forbidding transfer of such arms to third countries.
