(b) if so, the reaction of Government in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA) : (a) and (b) In September, 1967 the Gandhian Institute of Studies, Varanasi, organised a seminar to discuss the report submitted to the Administrative Reforms Commission by its Study Team on District Administration. In his opening remarks at the seminar, Shri Jai Prakash Narain is understood to have made a statement of the nature referred to in the question.

The Administrative Reforms Commission is going into the whole question of the reform of the administrative system.
