(v) Completion of buildings was unduly delayed by the contractors.

It is primarily for the University to appoint contractors and architects in accordance with the procedure laid down by it and to settle the audit objections. Also, it is for the State Government of Uttar Pradesh to take action, if any, in the matter in pursuance of the provisions of the Act of the University.
