2. For other sectors of industry the Sub-Groups recommended studies in depth as the first step, which is being done through exchange of detailed technical data.

3. These talks have been helpful in generating great interest in the exchange of automobile components, tractor parts, setting up of new textile mills in U.A.R. and the utilisation of the phosphatic deposits in UA.R. for setting up production facilities for fertilisers and supplying the requirements of the three countries in Phosphatic Fertilisers.
