THE MINISTER OF COMMERCE (SHRI DINESH SINGH): (a) Approximately 9.76 lakh bales costing about Rs. 88 crores.

(b) It is too early to make any precise estimate of the Indian cotton crop for the Cotton year 1967-68. The general expectation however, is that it would be about 20 per cent over the last year's figure.

## Power output of Neyveli Lignite Project

### 239. SHRI Z. A. AHMAD SHRI P. K. KUMARAN :

Will the Minister of STEEL, MINES AND METALS be pleased to state:

- (a) whether Government have examined the possibility of increasing the power output of Neyveli Lignite Project and also sharing of Neyveli power among the Southern States;
  - (b) if so, what are the results?

THE MINISTER OF STEEL, MINES AND METALS (DR. M. CHANNA REDDY): (a) A scheme for expansion of the present capacity of Neyveli Power Plant from 400 M. W. to 600 M.W. is under implementation. There is no proposal at present to expand the Neyveli thermal power station beyond the present sanctioned capacity of 600 M. W. The Government of India are considering how the surplus available power at Neyveli should lie utilized if Madras State Electricity Board are unable to consume the available power.

(b) The Neyveli Lignite Corporation are conducting negotiations with the Madras State Government and the Madras State Electricity Board.
