- (c) whether it is a fact that there is 15 per cent shortage of staff in the three polytechnics, if so, the steps taken to remove this shortage?

THE MINISTER OF EDUCATION (DR. TRIGUNA SEN) : (a) Of the three polytechnics, only the Kashmere Gate Polytechnic does not have its own workshops and laboratories. This Polytechnic is utilising workshops and laboratories of the Delhi College of Engineering and attached Technical Higher Secondary School.

Adequate facilities exist both for laboratories and workshops at Pusa Polytechnic. The Okhla Polytechnic has adequate facilities for laboratories but accommodation for workshops has yet to be provided.

(b) As soon as a decision regarding the location of the Kashmere Gate Polytechnic is taken, the necessary workshops and laboratories will be constructed.

For the Okhla Polytechnic construction of workshop buildings will be taken up in the current year.

(c) The shortage of staff is only five per cent. For the vacant posts, selections have been made and appoint ment of the necessary staff is in progress.
