#### DIVERSION OF FOODGRAINS TO INDIA

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHEB SHINDE) : Two ships for Ceylon, one carrying 9960 metric tons of rice from Thailand and the other carrying 8276 long tons of rice from Burma, were diverted to India by the Government of Ceylon at the request of the Government of India. The entire quantity of rice in both these ships was allotted to Kerala.
