(a) whether it is a fact that the Khadi Bhavan run by the Khadi Commission at Ranipur (Hardwar). U.P. has been closed down; and

(b) if so, what are the reasons therefor?]

INDUSTRIAL ENTERPRISES WITH EAST EUROPEAN COLLABORATION

618. SHRI M. C. SHAH: Will the Minister of INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS be pleased to state the number of industrial enterprises, established in private sector with collaboration of East European countries?

THE MINISTER OF INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMED): Between 1948 and end of March, 1964, Government approved technical collaboration arrangements with East European countries in respect of 61 parties in the private sector comprising of public and private limited companies, individuals and partnerships. Of these, 26 public and private limited companies had collaboration arrangements in force on April 1, 1961 or thereafter. This excludes collaboration arrangements entered into by individuals and partnerships as well as companies whose agreements expired prior to April, 1961.

Between April, 1964 and June, 1967, Government accorded approval to 30 parties in the private sector for collaboration arrangements with East European countries.

ADDITIONAL TRAIN ON DELHI-AMRITSAR ROUTE

619. SARDAR NARINDAR SINGH BRAR : Will the Minister of RAILWAYS be pleased to state:

(a) whether Government's attention has been drawn to the great overcrowding in direct trains between Delhi and Amritsar; and

(b) if so, whether any proposal to introduce an additional train on the route is under consideration?

THE MINISTER OF RAILWAYS (SHRI C. M. POONACHA): (a) Yes, there is overcrowding on some trains.

(b) Frequency of Airconditioned Expresses between Delhi and Amritsar has been increased from twice weekly to thrice weekly with effect from 1-4-1967.

Introduction of additional train between Delhi/New Delhi and Amritsar is not operationally feasible at present due to paucity of coaching stock and nonavailability of requisite line capacity on the saturated Delhi/New Delhi-Ambala section.
