#### SENIORITY LIST OF WIRELESS OPERATORS ON S. RAILWAY

THE MINISTER OF RAILWAYS (SHRI C. M. POONACHA): (a) and (b) There was no dispute about the implementation or otherwise of the seniority list of Wireless Operators prepared on the Southern Railway in accordance with Railway Board's orders. One Sri A. J. Stanley filed a writ petition in the Mysore High Court claiming that the above seniority list which was, in fact, a revision with effect from 19th June, 1982, should be given effect to retrospectively and th? promotions due to him from time to time in the former years should be given to him together with monetary arrears. This claim was admitted by the High Court of Mysore without questioning the principles governing the drawing up of the seniority list. Their verdict has been implemented. A similar writ petition in the Madras High Court by another affected employees has been rejected. Trie Board's intention was that the revised leniority list should be given effect to

in future and not retrospectively. In view of the position taken in the two High Courts, there is no need to change the orders of the Railway Board which are being carried out by the Southern Railway Administration. In the case of Sri A. J. Stanley, however, the High Court of Mysore's judgement has had to be carried out, although it was not in line with the policy directive of the Railway Board.

It has, therefore, been proposed, as an interim arrangement, that the Allov Steel Plant Durgapur will make stainless steel ingots and press-cog them into suitable slabs which will then be sent to Rourkela for roiling into hot bands of suitable thickness. A trial rolling is expected to take place very soon.
