**REFERENCE TO CALLING ATTENTION NOTICES RE FOOD SITUATION IN CERTAIN STATES**

SHRI BHUPESH GUPTA (West Bengal): Mr. Vice-Chairman, before the House adjourned we wanted to raise several issues. The new Chairman was there and we did not want to disturb him. We have given a series of calling attention notices with regard to the food situation in Kerala, West Bengal, Uttar Pradesh and Bihar. Now the situation has specific features. The Central Government is not making fresh supplies available to them even to maintain the ration in West Bengal, Kerala and other places, although, as you know, the rationing was undertaken on the assurance from the Central Government that the Central Government would keep up the supplies at least for statutory rationing and also or modified rationing. We find from the Ministers and other sources of those Governments that they are not making even a small fraction of the committed assistance, monthly assistance, available to the West Bengal Government or Kerala. For example, West Bengal is supposed to get 75,000 tonnes of foodgrains from the Centre every month. Only a small quantity has gone these and the statutory rationing is on the point of breaking down. Kerala relies on food from outside to the extent of 50 per cent of Kerala's requirements, and there again I think the commitment is for 50,000 tonnes a month. There again we find that only a very small quantity has gone. We are told, Mr. Vice-Chairman, that the ships are not arriving. But when the West Bengal Government want to internally procure foodgrains by
