The decontrol of pricing and distribution of steel would not, therefore, affect his other functions which include the enforcement of the Iron and Steel (Control) Order, 1956, import and export of steel, development of iron and steel producing units, assistance to the Steel Priority Committee, Joint Plant Committee Steel Exporters' Association, etc.

(b) The Iron and Steel Controller has been asked to work out the number of employees who would be rendered surplus as a result of decontrol. The services of the surplus staff will be placed at the disposal of the Ministry of Home Affair, who have a scheme for the deployment of surplus personnel. The Department of Iron and Steel are also trying to find alternative employment for them in the Public Sector Undertakings under their control.
