AMOUNT ALLOTTED IN ANDHRA CIRCLE OF P. & T.

361. SHRI YELLA REDDY: SHRI P. K. KUMARAN:

Will the Minister of COMMUNICA-TIONS be pleased to state:

(a) the amount sanctioned, allotted and spent in Andhra Circle of the

P and T Department towards the acquisition of sites, construction of departmental buildings and staff quatters during the financial year 1966-67; and

(b) the sanctioned amount which lapsed and the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND COMMUNICATIONS (SHRI I. K. GUJRAL): (a) A number of works for acquisition of sites and construction of departmental buildings and staff quarters are sanctioned in each Circle and allotments against different works are made according to available resources. In Andhra Circle the total allotment made during 1966-67 for land acquisition and construction of all types of buildings was Rs. 22.14 lakhs and expenditure Rs. 22.38 lakhs.

(b) There has been no lapse—rather there has been a slight excess expenditure over the allotted funds.

PLAN ALLOCATIONS FOR ANDAMAN AND NICOBAR ISLANDS

362. SHRI YELLA REDDY: SHRI P. K. KUMARAN:

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that plan allocations for the Andaman and Nicobar Islands under the Third Five Year Plan were not fully utilised; and
- (b) if so, what were the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA):
(a) Yes, Sir. A sum of Rs. 617.31 lakhs i.e. 63 per cent of the total outlay of Rs. 979.32 lakhs was utilised.

- (b) The shortfall of Rs. 362.01 lakhs in expenditure was due mainly to:
  - (i) Difficulty of communications between the Mainland and Islands and also within the Islands with the resultant difficulty of novement of men and materials;
