THE MINISTER OF TRANSPORT AND SHIPPING (PROF. V. K. R. V. RAO): (a) It is a fact that this old bridge is rather weak. Load restrictions have, therefore, been imposed and the .traffic on the bridge is restricted to one lane of truck traffic having laden weight of 33,000 lbs. at

a time. The work of reno/ating the decking of the bridge has also been sanctioned, and is in progress.

(b) and (c) It is proposed to construct during the fourth five-year plan period a new bridge near the site of the existing bridge. The detailed proposals in this regard are awaited from the Government of Maharashtra. The bridge will take about two years for completion after it is sanctioned.
