#### HIMACHAL IN PUNJAB WHEAT ZONE

291. SHRI SURJIT SINGH ATWAL: Will the Minister of FOOD AND AGRICULTURE be pleased to state:

(a) whether it is a fact that a suggestion has been made by the Government of Himachal Pradesh that the State of Himachal Pradesh be included in the Punjab Wheat Zone;

(b) if so, what is Government's reaction thereto; and

(c) whether the Government of Punjab is agreeable to this suggestion?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND CO-OPERATION (SHRI ANNASAHEB SHINDE): (a) Yes, Sir.

(b) and (c) The decision to make Punjab and Himachal Pradesh into single State Zones was taken only in April, 1967 at the Conference of Chief Ministers held in New Delhi and it is too early to think of a revision.

#### TONNAGE OF SHIPPING

THE MINISTER OF TRANSPORT AND SHIPPING (PROF. V. K. R. V. RAO): (a) and (b) A total of 4.56 lakh tonnes GRT ply in Indian waters. Of this 97 vessels aggregating 3.67 lakh tonnes GRT are owned by India companies.

[THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND CO-OPERATION (SHRI ANNASAHEB SHINDE): (a) and (b) No specific monthly quota of wheat or rice has been fixed for States. Allocations are made each month depending on the availability of grains with the Centre for that month. In the case of sugar, cuts have been applied uniformly to the quotas of all the States except in the case of Delhi and Chandigarh where the full cut has not been applied. The releases of sugar may, however, be rephased in some cases in response to the requests of the State Governments.]

#### RABI HARVEST IN STATES

\*295. SHRI R. P. KHAITAN: Will the Minister of FOOD AND AGRICULTURE be pleased to state:

(b) the quantity of foodgrains imported from each country during the last ten months?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND CO-OPERATION (SHRI ANNASAHEB SHINDE): (a) and (b) Two statements are laid on the Table of the Sabha.

#### STATEMENT i

Only qualitative reports have been received so far; firm estimates based on actual areas enumeration and crop-cutting surveys are expected to become available after the close of the current agricultural Year i.e. in July, 1967. According to tentative indications, production of wheat is expected to be higher than last year, while production of gram is likely to be considerably less than last year. Production of barley is expected to be about the same level as last year.
