SMALL SCALE INDUSTRIES IN KASHMIR

- 549. SHRI GULAM NAB.I UNTOO: Will the Minister of INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS be pleased to state:
- (a) whether any survey has so far been conducted to study the prospects of developing small-scale industries in the Kashmir Valley; and
 - (b) if so, the details of the report?

THE MINISTER OF INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMED): (a) Yes, Sir.

(b) Th_e office of the Development Commissioner (SSI) conducted the first techno-economic survey of Jammu and Kashmir State in 1959-60 to assess the potentialities for the development of small scale industries in the State. The major findings of the report were as follows:

Jammu and Kashmir State though rich in forests, fruits and minerals, many of which still remain to be fully assessed and exploited is deficit in food and imports anuually large quantities of it from other parts of 'India. Among the biggest hurdles coming in the way of the State's economic development, mention may be made of the irregular and expensive transport system, absence of industrial lending by banks, dearth of skilled workmen dependence on imports of food and other supplies from the rest of the country.

All these hurdles were examined in the report and suggestions to overcome them were made wherever possible.

The second survey was conducted in the year 1966 by a team of officers with the object of assessing the possibilities of developing the small scale industries in the State and for indicating the manner in which the industrial estates could be revitalised and raw materials and finances secured for the industries in the State. I

The major recommendations of the team are as under:

to Questions

- (i) The State Government should be given an ad hoc allotment of foreign exchange of Rs. 20.00 lakhs so as to meet the immediate requirements of imported scarce raw materials required by the small scale industries in the States.
- (ii) In order to assess their regular requirement a team of experts from the Central Small Industries Organisation should make an assessment of each unit with regard to their raw material requirement;'
- (iii) The industrial units (food preservation units) requiring tin plate in the State should be brought at par with similar units in other parts of the country and the Ministry of Food and Agriculture should make an allotment of tin plate to them for this purpose;
- (iv) Private woollen mills in the State should be recognised 'by the Textile Commissioner for supply of basic raw material and to meet their immediate requirement an ad-hoc allotment of 75,000 lbs. of wool-tops may be-made to them;
- (v) State Government should take up the question of reopening the plywood factory (private enterprise) which is lying closed for want of essential raw materials: and
 - (vi) The State Government as well as the Small Industries Service Institute. Srinagar need augmenting their technical staff. Accordingly it has been suggested that they should strengthen their technical extension service by recruiting qualified persons even by offering them special allowances and also start common facility workshops at Srinagar and Jammu.

As recommended by the Second Survey assessment of raw material requirements of Small Scale Industries in the State of Jammu and Kashmir was made by a team of experts, for the purpose of assessment of raw materials the industries have been divided into four categories: (i) Metal working industries, (ii) rubber, plas'ir and pharmaceutical industries, (iii) soap making and (iv) fruit preservation and canning, bakery and industrial brushes. The requirements of all engineering and non-engineering industries in the State of Jammu and Kashmir have been since estimated unit-wise by the team of experts.
