- (1) No change was considere" cessary in the existing policies governing the entry of migrants from East Pakistan into India and their eligibility to receive relief and rehabilitation assistance from the Government.
- (2) The State Governments should take full advantage of the offer on a no-profit-noloss basis of the spare capacity of the Rehabilitation Reclamation Organisation for State projects involving large-scale reclamation of land. They were requested to intimate their requirements to the Department of Rehabilitation.
- (3) The families of displaced persons should be moved to the villages according to a planned and phased programme, which should be drawn up well in advance and ndhered to, as far as possible.,
