GUJ-RAL): (a) 638 Post Offices are likely to be opened in border areas and areas treated as 'Very Backward' by P&T Department. Opening of Extra Departmental Branch Offices will depend upon the removal of the existing restrictions placed due to the financial stringency. Saharsa District is not treated as 'Very Backward' for of expansion of postal the purpose facilities. 62 Post Offices are likely to be opened in Saharsa Diett.

STATEMENT

Some of the important decisions taken at the Rehabilitation Ministers' Conference held on the 17th May, 1967

- (1) No change was considered necessary in the existing policies governing the entry of raigrants from East Pakistan into It dia and their eligibility to receive relief and rehabilitation assistance from the Government.
- (2) The State Governments should take full advantage of the offer on a no-profit-no-loss basis of the spare capacity of the Rehabilitation Reclamation Organisation for State projects involving large-scale reclamation of land. They were requested to intimate their requirements to the Department of Rehabilitation.
- (3) The families of displaced persons should be moved to the villages according to a planned and phased programme, which should be drawn up well in advance and adhered to as far as possible.
