## DR. D. V. PARAB'S HELICOPTER TRIP FROM KAZA STATION TO SIMLA

- 638. SHRI A. D. MANI: Will the Minister of COMMUNICATIONS be pleased to state:
- (a) whether it is a fact that on April 1 last a helicopter wa<sub>s</sub> used to transport Dr. D. V. Parab from Kaza Station to Simla in Himachal Pradesh;
- (b) if so, how much did the trip cost the P&T Department; and
- Ce) whether similar assistance has been given to other employees in the past?
- THE MINISTER OF STATE IN THE DEPARTMENTS OF PARLIA AND **MENTARY AFFAIRS** COM MUNICATIONS (SHRI I. GUJRAL): (a) Yes, Sir, an I.A.F. specially used helicopter was 31st March last to air-lift Shri D. V. Parab, Wireless Operator at Kaza to Chandigarh.
- (b) The expenditure would be about Rs. 10.000.
- (c) There has been no such occasion in the past. In this case, however, the official suddenly had a heart attack. No medical aid was available at Kaza or near about. This emergency c'alled for an immediate action and arrangement to air-lift him to Chandigarh, where adequate medical facilities were available.

## VACANT POSTS FOR SCIENTISTS

- (a) whether it is a fact that Dr. Husain Zaheer made a statement at Delhi recently to the effect that 4500 posts for scientists are lying vacant in the country; and
- (b) if so, what steps are being taken to recruit scientists for these jobs?

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SHRI BHAGWAT JHA AZAD): (a) According to Press reports, Dr. Husain Zaheer made such a statement at a recent Seminar organised by the Harvard Club. Government have no information regarding the statement apart from what has appeared in the Press.

(b) In so far as Government Departments/Organisations are concerned, the vacant posts are being filled in the normal way in accordance with the prescribed rules for recruitment to the concerned posts.
