THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI K. S. RAMASWAMY): (a) and (b) Yes, Sir. One examination was held by the Union Public Service Commission in October, 1966. Twenty-five candidates have been recommended by the Commission for appointment to the all-India and Central Services on the basis of this examination.

#### **MAN-DAY LOSS DUE TO GHERAOS**

681. SHRI RAM CHANDER: Will the Minister of LABOUR AND REHABILITATION be pleased to state:

(a) what was the total man-day loss due to the gherao movement so far; and

(b) whether the system of Arbitration Boards is being considered for settling such grave differences as lead to gheraos; if so, what decision has been taken in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR, EMPLOYMENT AND REHABILITATION (SHRI L. N. MISHRA): (a) Information is not available.

(b) The Government of India have advised all State Governments to have greater recourse to voluntary arbitration for the settlement of industrial disputes whenever bipartite discussions and conciliations fail.

#### **THUNDER-STORM IN FAMINE-STRICKEN AREAS OF BIHAR**

(a) whether a heavy thunder-storm lashed different parts of the famine-stricken areas of Bihar recently;

(b) if so, the extent of damage to life and property caused by the storm; and

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI K. S. RAMASWAMY): (a) and (b) Reports of thunder-storm over four districts received so far reveal death of two persons<sup>ant\*</sup> damages caused to fruit and foodgrain crops only.
