THE MINISTER OF EDUCATION (DR. TRIGUNA SEN): Sir, I beg to lay on the Table a copy of the Report of the Committee of Members of Parliament on Education (1967)—national policy on education.

SHRI BHUPESH GUPTA (West Bengal): Sir, I have a serious submission to make in this connection. We are now having the report laid on the Table of the House. On the very day when the recommendations were announced and the Government also announced its policy with regard to language, on the same day the A.I.R. made a broadcast for fifteen minutes against the decisions of the Government, against the clearly indicating that it was interested in informing public opinion against it. I should like to know what is the policy of the Government, I should like to know whether the A.I.R. policy is the Government policy which permitted this kind of broadcast over the language question repudiating the Government's position and the recommendations of the Committee, or whether what we are getting from the hon. Minister represents the Government policy.

DR. TRIGUNA SEN: I cannot answer to this policy matter of the Ministry of Broadcasting. I personally have not heard what was discussed in the Radio. As soon as a decision was taken on this language issue by the Government. I placed it before the House the next day.

SHRI BHUPESH GUPTA: What I say is this. We are being given this thing. Another Minister on the same day when things were known arranged a broadcast directed against the decisions of the Government. Let him make an enquiry from the A.I.R. and let us know what exactly is the position.

SHRI G. RAMACHANDRAN (Nominated): I remember this talk on the Radio to which Mr. Bhupesh Gupta refers. It was somebody from the staff of the "Hindu"-I the name-he made a long speech in which he gave powerful support to of English in the retention the manner in which some of the people of India still want it to be retained.
