REQUIREMENT OF FOODGRAINS DURING THE CURRENT YEAR

*422. SHRI SURJIT SINGH WAL: Will the Minister of FOOD AND AGRICULTURE be pleased state the total requirements of foodgrains during the current year?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRI-CULTURE, COMMUNITY DEVELOP-MENT AND CO-OPERATION (SHRI ANNASAHEB SHINDE): There has been no national survey on the consumption of foodgrains in India so far. The requirements of foodgrains are also elastic to some extent, depending on the availability of foodgrains and of other substitute foodstuffs, their comparative prices, level of income, etc. It is, therefore, not possible to indicate any precise requirement of foodgrains in India for the current year. On a rough calculation of the estimated production and the demands from State Governments, . modified by past experience of variation between demands and actual supplies, it is considered that a minimum import of 10 million tonnes of foodgrains from abroad would be neces. sary.
