(a) whether it is a fact that the Government of India is considering a proposal to start subsidised sale of rice in some of the States; and

(b) if so, the details of the proposal?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND CO-OPERATION (SHRI ANNASHEB SHINDE): (a) No, Sir. The supply of coarse rice from Central stocks to the States is already subsidised.

THE MINISTER OF TOURISM AND-CIVIL AVIATION (DR. KARAN SINGH): (a) and (to) The Indian Airlines office building in Bhavnagar was not burnt though all assets including furniture, fixtures, safe, cash-box, cash value documents, records and cargo consignments and all stationery were thrown out of office on the read and burnt by the mob on 22nd and 23rd May, 1967. The total loss is estimated at about Rs. 25,000

CONSTRUCTION OF ROADS IN MADHYA PRADESH
