PAK. MICRO-WAVE TELECOMMUNICA-TION CHANNELS THROUGH NEPAL

787. SHRI N. R. MUNISWAMY: Will the Minister Of EXTERNAL AF FAIRS be pleased to state:

- (a) whether it is a fact that the Nepalese Government have permitted Pakistan to establish micro-wave telecommunication channels linking East Pakistan with West Pakistan; and
- (b) if so, whether such facility will put India in a disadvantageous position in the event of any future hostilities between India and Pakistan?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI M. C CHAGLA): (a) According to information available to Government, a Pakistani proposal to establish Microwave stations in Nepal designed to provide a telecommunication link between West and East Pakistan is under consideration of His Majesty's Government of Nepal.

(b) As the question involves relations between two sovereign Governments one of whom is a friendly neighbour, Government of India wish to make no comment on this issue. However, the security aspects of any such development are constantly under examination by the Government of India.

INDIAN DIPLOMAT IN DRUG RACKET

THE MINISTER OF EXTERNAL AFFAIRS (SHRi M. C CHAGLA): (a) The Ministry of External Affairs is aware of the press report appearing in the 'Hindustan Times' of 22nd May 1967 and have made enquiries in the matter.

(b) Our enquiries have so far revealed that no diplomat, senior or junior, or any other official of the Indian High Commission, London is involved in a drug racket. Indian High Commission in London has already taken up with the British Government the matter of publication of incorrect reports in the papers.

THE MINISTER OF INFORMATION AND BROADCASTING (SHRI K. K. SHAH): It is proposed to start Commercial Broadcasting as a pilot project from Bombay All India Radio Station with effect from 15th August 1967.

Details about the channels, rates, etc. are under consideration.

POPULARISATION OF TELEVISION

790. SHRI SURJIT SINGH ATWAL: Will the Minister of INFORMATION AND BROADCASTING be pleased to state the scheme formulated by Gov ernment to popularize T. V. in India?

THE MINISTER OF INFORMATION AND BROADCASTING (SHRI K. K. SHAH); Television by itself is a very powerful and effective medium of mass communication. No separate scheme for popularising television is considered necessary or has been drawn up.

The Fourth Five-Year Plan of All India Radio, as approved by the Planning Commission, provides for the setting up of Television Stations at Bombay, Calcutta, Madras and Kanpur besides the expansion of Delhi TV Centre. Progress would, however, depend upon availability of funds and necessary foreign exchange required for the purpose.

DEPARTMENTS ATTACHED TO INFANTRY LINITS

Education Corps have training centre* of their own. There is no separate Corps for Movement Control or for Welfare in the Army. Officers, JCOs and ORs are drawn from various Arms and Services on extra regimental employment for Movement Control duties and they pick up their duties in the concerned Units or detachments. Similarly the 'A' staff at various H.Q. formations who also are drawn from various Arms and Services plan and execute welfare matters.
