THE MINISTER OF DEFENCE (SARDAR SWARAN SINGH); (a) Yes, Sir.

(b) Necessary measures to safeguard the security of the country have been taken. Some idea of this is given in the annual report of the Ministry of Defence which the hon'ble Member may have seen.

AID TO SINGAPORE, KENYA AND MALAYSIA

STATEMENT

The following is the assistance offered by India to Singapore, Kenya and Malaysia during the years 1965—37.

Singapore.—Training places were provided in India for 12 personnel from Singapore and the services of 1 expert was made available. A gift of 1 Pushpak aircraft manufactured by H.A.L. was announced by the Foreign Minister during his visit to Singapore in May, 1967.

Kenya.—A credit of Rs. 2.5 crores has been extended to the Government of Kenya for the purchase of -ailway rolling stock and other railway equipment from India. The specific items to be covered and terms and conditions are under negotiations between the two Governments.

Training places were provided to 82 persons and 5 experts were deputed to Kenya during the period.

Malaysia.—137 nationals of Malaysia were provided training facilities and the services of 4 experts have been made available

During his visit to Malaysia in May, 1967, the Foreign Minister announced the presentation of 1 Pushpak aircraft and two gliders.

THE PRIME MINISTER (SHRIMATI INDIRA GANDHI): (a) Yes.

- (b) Consistent with its charter of duties, the Scientific Advisory Committee to the Cabinet is concerned with scientific and technological matters of wider application, either *suo motu* or on references received from Ministries etc. The recommendations of the Scientific Advisory Committee to the Cabinet cover a wide range of subjects including the formulation and implementation of the Government's scientific policy, coordination of scientific work among Ministries of Government, semi-Governmental and non-Governmental scientific institutions in the country.

(b) The former Vice-President, Mr. Nixon, is not a member of the U.S. Government and the question of assurances by him on behalf of the U.S. Government does not arise.

JOURNALIST AS DIRECTOR GENERAL OP EXTERNAL PUBLICITY

*458. SHRI M C. SHAH: Will the Minister of EXTERNAL AFFAIRS be pleased to state the decision taken on the proposal to appoint a top level Journalist as Director-General of External Publicity'

THE MINISTER OF EXTERNAL AFFAIRS (SHRI M. C. CHAGLA): At one time a proposal was considered to appoint a Journalist in the Ministry of External Affairs to deal with external publicity, but on further consideration it was decided not to pursue the matter, and to continue the practice of having a Foreign Service officer to deal with publicity, as has been the case since 1947.
