CANCER PATIENT

*482. SHRI MAHAMMED HANEEF: Will the Minister of HEALTH AND FAMILY PLANNING be pleased to refer to answer given to Starred Question No. 159 in the Rajya Sabha on the 29th March, 1967 and state:

(a) the total number of patients now suffering from cancer in the country; and

(b) the number of patients who are being treated in the 3 Cancer Research Centres?

DISTRIBUTION OF PETROLEUM PRODUCTS

(a) the details of the present position in regard to the distribution of petroleum products in the country;

(b) whether the disinclination of the British Oil Companies to distribute Soviet products has since been overcome;

(c) whether the Burmah-Shell have followed the Burma Oil Company in taking part in such distribution;

(d) whether the public sector company has begun operating distribution work; if not, the reasons therefor;

(e) whether the refinery set up with Russian collaboration in Eastern India has begun production; and

(f) whether the expectation of more petroleum products from Kuwait has been realised?

THE MINISTER OF PLANNING, PETROLEUM AND CHEMICALS AND SOCIAL WELFARE (SHRI ASOKA MEHTA): (a) The distribution of bulk refined petroleum products in India is handled by the following companies:—

(i) Indian Oil Corporation Limited,

- (ii) Burmah-Shell Oil Storage and Distributing Company of India Limited,
- (iii) Esso Standard Eastern Inc.,
- (iv) Caltex (India) Limited,
- (v) Assam Oil Company Limited,
- (vi) Indo-Burmah Petroleum Company Limited.

Certain other companies deal in lubricants, greases and specialities only.

(b) and (c) No. Sir.

(d) The Indian Oil Corporation is organised to undertake distribution of petroleum products all over the country.

(e) The Refinery at Barauni went on stream in 1964 with the first million ton unit. The second million ton unit has also since been commissioned.

(f) There has been no need nor expectation of Petroleum product imports from Kuwait.
