the Consortium has already appreciated. Canada has pledged food assistance worth U.S. \$46 million. Supply of 1.5 million tonnes under U.S. PL-480 is expected to be authorised shortly. Besides direct food assistance, indirect assistance can be in the shape of financing fertilizers, pesticides etc. for growing more food, or of debt rescheduling and other types of assistance which would release our cash resources for the purchase of food on World markets. The nature and extent of assistance of the latter type is under consideration of the member countries and institutions of the Consortium.

A part of this is expected to be met from inflow of private foreign capital and the rest represents the requirements of foreign aid in the shape of loans and grants.
