†[THE MINISTER OF WORKS, HOUSING AND SUPPLY (SHRI JAGANNATH RAO): (a) There is no proposal to draw up a New Master Plan or make any fundamental changes in the Master Plan for Delhi. Some modifications are, however, made in the Master Plan as and when found necessary, in accordance with the provisions of the Delhi Development Act, 1957.

(b) The Master Plan of Delhi does not mention the names of unauthorised colonies. It has, however, been decided that unauthorised constructions put up before 1st September, 1962, i.e., the date of coming into force of the Master Plan which are of a substantial nature and do not violate the land use pattern of the Master Plan and which can be fitted into layout/service plans of their areas may be regularised.]
