# S.T.C. ENTRY INTO NEW FIELDS OF EXPORT

## \*500. SRHI SITARAM JAIPURIA: SHRI K. SUNDARAM:

Will the Minister of COMMERCE be pleased to state;

- (a) whether it is a fact that the State Trading Corporation has taken a decision to enter into new fields of exports this year;
- (b) if so, what are the new fields where it proposes to enter;
- (c) whether Government have been consulted by State Trading Corporation before taking such a decision; and
- (d) the extent to which the private trade is likely to be affected by such an entry?

THE MINISTER OF COMMERCE (SHRI DINESH SINGH): (a) Yes, Sir.

- (b) The State Trading Corporation is constantly endeavouring to expand foreign trade and build up new lines of export to the various markets, which are not moving on their own, as well as to further the export of traditional items to non-traditional markets.
- (c) Government approval is obtained wherever required.
- (d) It will depend upon the extent to which private trade is unable to compete. However the effort of S.T.C. has been to promote and not restrict trade unless it was likely to introduce unhealthy trends.
