(b) No, Sir. A few manufacturers have applied to the Indian Standards Institution for the certification mark.

(c) and (d) The Drugs and Cosmetics Rules, 1945 have been amended whereby clinical thermometers not bearing I.S.I. Certification mark will be subject to licensing in accordance with the provisions of the said Rules.

PASHMINA WOOL INDUSTRY IN LADAKH

- 501. SHRI BHUPINDER SINGH: Will the Minister of COMMERCE be pleased to state:
- (a) whether it is a fact that the Pashmina Wool industry in Ladakh has been facing crisis for some time;
- (b) if so, what are the reasons therefor; and
- (c) what steps Government propose to take to remedy the situation?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI MOHD SHAFI QURESHI): (a) to (c) The Pashmina Wool industry Ladakh has been facing crisis because of stoppage by China of trade between Ladakh and Tibet. The Jammu and Kashmir State Government have started a Pashmina Development Farm in Chang-Phang area with a base flock of 1000 animals where efforts are being made to experiment on improvement of quality of Pashmina and propagation among local herdsmen. Local people are also making vigorous efforts to augment pashmina production as 26.538 pashmina goats are being reared in Ladakh.
