INDIAN DIPLOMATS' FAMILIES IN PEKING

(a) whether any of the families of Indian diplomats at Peking have returned to India since 15th June, 1967; and

(b) whether any Indian staff has been sent to our Embassy at Peking since 15th June 1967?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI M. C. CHAGLA): <a) Yes, Sir.

<b) No, Sir.

INDIANS COMING FROM KENYA

648. SHRI SITARAM JAIPURIA: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

(a) the number of persons of Indian origin who are at present living In Kenya;

(b) the number of such persons who have come to India during the last six months and the reasons for their coming;

(c) what steps have been taken to rehabilitate them; and

(d) whether these persons were allowed to bring their belongings?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI M. C. CHAGLA): (a) There are approximately 188,000 Asians, mainly of Indian origin who are at present living j_n Kenya.

(b) During the last 6 months o<ir High Commission has record of 82 persons having applied for repatriation facilities for their return to India. These persons have come back to India for permanent resettlement due to uncertainly about their future in Kenya.

(c) and (d) The Government of India have extended to all repatriates from East African countries, certain liberal customs and I.T.C. concessions which have, to some extent, eased the process of their rehabilitation. These concessions include duty-free entry of personal belongings as well as stocks in trade, etc. In addition, repatriates are permitted to import their personal motor cars and in some cases, where these vehicles have been in the possession of repatriates for a period of one year or more prior to their arrival, entry is permitted free of duty.

WIRELESS COMMUNICATION FACILITY IN INDIAN EMBASSY IN PEKING

649. SHRI BHUPINDER SINGH: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

(a) whether the Government of India have direct wireless communication facility with our embassy in Peking;

(b) if not, whether they are considering a proposal to have such a facility soon; and

(c) how Government propose to remain in touch with our embassy in

Peking in the event of the telephone or cable system in Peking going out of order?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI M. C. CHAGLA;: (a) and (b) The Indian Embassy in Peking, like other Indian Missions abroad, has been provided with a teleprinter set through which they receive transmissions broadcast by the Overseas Communication Services. This is only a one-way traffic. No proposal for having a two-way wireless communication link with the Embassy in Peking is under consideration of Government at present.

(c) There was no break-down In the telephone or the cable system in Peking even in Jun_e last when the strained relations with China reached its peak. If such contingencies arise contact can be maintained through Courier service.
