SHRI SITARAM JAIPURIA: The Minister mentioned about some special circle for assessment of the higher income groups. May I know if it has come to his notice that many assessments are done when they are barred by limitation of time? Has he any information to show that out of the assessments done in the last 2 years, how many were done when it was just the time for being time-barred?

SHRI K. C. PANT: I do not have the information.

श्री कें सीं पन्त: जी हां, विशेष कदम उठाने की सोच भी रहे है और कुछ उठाएं भो हैं इसीलिये इनकम टैक्स ग्राफिसर्स जो कम ग्रामदनी वाले कैसेज हैं उनमे कम समय जाया करेंगे और ज्यादा ग्रामदनी वाले केसेज में ध्यान केन्द्रित करेंगे, और जो स्ट्रक्चरल चेन्चेज की ात मैंने कहीं वह भी करेंगे।

KEROSENE UNIT OF THE GAUHATI PLANT

*355. SHRI BHUPINDER SINGH: Will the Minister of PETROLEUM AND CHEMICALS be pleased to state:

(a) whether it is a fact that idle time in the Kerosene Unit of the Ginhati Plant increased from 3.6 per cent, in 1962 to 45 per cent, in 1965;

(b) what is the amount of loss ia terms of money on account of the plant remaining idle from 1962 to 1965;

- (c) what are the reasons for the plant remaining idle; and
- (d) what are the steps taken by Government to remedy the situation?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND OF PLANNING AND (SHRI WELFARE SOCIAL K. RAGHURAMAIAH); (a) It is not clear how the figures of 3.6 per cent, and 45 per cent, have been arrived at. However, during 1905, the Kerosene refining unit of Gauhati Refinery operated for 45 days as against 85 days during 1962.

- (b) There is no loss, as the restricted operation of the Kerosene Unit does not affect either the refinery throughout or the overall production.
- (c) The operations of the kerosene refining unit are limited in extent of the demand for iomex and the economics of operating the unit.
- (d) The present situation does not call for any remedial steps.

SHRI BHUPINDER SINGH: May I know from the Minister when it came to the notice of the Government that the Gauhati plant was working to almost half its capacity? When did the Government take remedial steps and have the remedial steps vielded results? How does the idle time in 1966 compare with the idle time in 1965?

SHRI K. RAGHURAMAIAH: 1 presume he is referring to the kerosene unit. The kerosene unit worked for 85 days in 1962 and during 1965 it worked for 45 days. If I explain the working, probably my friend will understand. In a distilling unit there is a kind of kerosene which is more in the nature of inferior kerosene. When it is put in the kerosene refining unit, then it gives superior kerosene leaving also a quantity of iomex

Therefore the functioning of the refining unit depends upon the demand for iomex. If the demand is less then we will have to sell the thing straight from the distilling unit as inferior Kerosene. That is what has happened in these years.

SHRI BHUPINDER SINGH: May I know whether the management of the plant was also in any way responsible for the underutilisation if the plant capacity? Did they do anything to rectify the situation .at their own level before the Central Government stepped in? Has this under-utilisa-tion of the plant resulted in pushing up the sale price of kerosene oil?

SHRI K. RAGHURAMAIAH: 1 have already said that there is no loss or reduction in the overall output. It is true that they are selling inferior kerosene straightway because sometime back they experimented mixing iomex with inferior kerosene, but it was not a success. The Corporation are exploring whether we can find a suitable way of using iomex. If they cannot, they may sell it all as inferior kerosene. There is no loss. I am sorry the hon. Member has mentioned the management in this connection. The management has nothing to do with this. It is just a question of finding a market for the products.

SHRI KOTA PUNNAIAH: May I know whether there is any retrenchment at Gauhati unit and, if so, what is the likely number?

SHRI K. RAGHURAMAIAH: Sir, I would require a separate notice for that question.

MEMORANDUM ON INDIA'S PROBLEMS AND BIRTH CONTROL

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND-FAMILY PLANNING (SHRI B. S. MURTHY): (a) A memorandum will be sent shortly.

SHRI HARISH CHANDRA MATHUR: Sir, the hon. Minister, 'When he was replying to this question on an earlier occasion, had stated 1hat they had taken a decision in the Cabinet and it was in pursuance of 1hat Cabinet decision that he was meeting the religious heads. May I now ask, what was the nature of that Cabinet decision and how is it that he decided and thought it fit to go .aid meet His Holiness the Pope out-J ide this country without first contacting the Sankaracharyas in this country, and the Maulvis and Mullas and the Jain and Buddhist radhus £1 nd saints, who have a much greater Mid larger impact on the religious susceptibilities of the people? Therefore, I would like to know what are the directions which the Cabinet had given to the hon. Minister and how b» arranged the priorities and what is his programme for the future.

SHRI B. S. MURTHY: I am afraid I cannot say anything about the C'ubinet decision. But as far as the Minister meeting the Pope is concerned, the Minister had gone to attend the World Health Conference in
