TRADE DEFICIT IN COLOMBO PLAN COUNTRIES

*365. SHRI KESAVAN (THA ZHAVA) : SHRI NIREN GHOSH: SHRI ARAVINDAKSHAN KAIMAL:

Will the Minister of FINANCE be pleased to state:

(a) whether the Fourteenth Annual Report prepared by the Colombo Plan Consultative Committee has pointed out the growing trade deficit in the developing countries in the Colombo Plan region;

(b) if so, what is the extent of this deficit; and

(c) the share of India in the total trade deficit during the years 1963 and 1965?

THE DEPUTY PRIME MINISTER AND MINISTER OF FINANCE (SHRI MORARJI R. DESAI): (a) Yes, Sir.

(b) The visible trade deficit of the countries in the Colombo Plan area widened from \$ 1,968 mil ion in 1963 to \$ 2,281 million i_n 1965.

(c) India's share in the total trade deficit was \$ 854 million in 1963 and \$ 1,235 million in 1965.

 (a) whether it is a fact that a private dairy is functioning within the premises of the C. P.
W. D.- Enquiry Office, Netaji Nagar, New Delhi;

(b) whether it is also a fact that the dairy owner has compelled the Government not to complete the boundary wall and keep an outlet for the dairy;

(c) if so, the reasons why Government have yielded to the unauthorised occupation by the private dairy during the last five years; and

(d) what steps to remove the dairy have been taken during the above period?

THE MINISTER OF WORKS, HOUSING AND SUPPLY (SHRI JAGANNATH RAO): (a) and.(b). Yes. There is a^o an unauthorised tea stall in the premises. Because of the presence of the squatters, the boundary wall could not be completed.

(c) and (d). The squatters could not be evicted because they had in their possession a stay order from a competent court. Steps have since been taken to evict them with the help of the Police.
